Surviving spouses whose officer passed away 1/1/89 and after are paid by the schedule above.

All Orphans whose officer passed away receive \$ 9776.76 annually or \$814.73 per month (20%). All children continue to receive this amount to age 18 or to age 23 if enrolled in an accredited institution of higher learning. Benefits cease when the child is no longer in school or reaches 23 years, unless the orphan suffers from a physical or mental disability. In the case of a disability, the benefit continues for the lifetime of the disability.
