Dear Hockey Friends:

The **Georgia Field Hockey Association, Inc. (GFHA)**, an affiliated member of the United States Field Hockey Association, Inc. (USFHA), would like to extend an invitation to the **2008 Atlanta Cup International Field Hockey Tournament**, scheduled for **October 11 & 12, 2008**.

This outdoor event will be played on two AstroTurf surfaces located on the campus of the Georgia Institute of Technology here in Atlanta, Georgia. The tournament will feature up to eight men's and eight women's teams from the U.S. and abroad. The competition will be played under FIH Rules and Regulations.

The registration fee has not yet been determined. Note, however, that a team deposit of \$400 must be submitted by August 31, 2008. The final payment is due on the night of registration, Friday October 10, 2008. This fee includes a **Welcome Reception** on Friday evening and a **Dinner Banquet** (one ticket per player) on Saturday.

Our host hotel for the tournament is the [Renaissance Atlanta Hotel Downtown](#). Their guest room rate for the tournament is \$121 plus tax for up to four (4) persons per room. In order to lock in the room rate of \$121, hotel reservations must be made before September 9, 2008.

All players must sign a **Waiver and Release of Liability** form, which will be forwarded to any team accepted into the tournament. Attached is an official Entry Form to be completed, signed and returned along with a check or money order made payable to **GFHA, Inc.** to the following address:
