Dear Hockey Friends:

The **Georgia Field Hockey Association, Inc. (GFHA)**, an affiliated member of the United States Field Hockey Association, Inc. (USFHA), would like to extend an invitation to the **2009 Atlanta Cup International Field Hockey Tournament**, scheduled for **October 3 & 4, 2009 (one week earlier than usual)**.

This outdoor event will be played on two Astroturf surfaces located on the campus of the Georgia Institute of Technology here in Atlanta, Georgia. The tournament will feature up to eight men's and eight women's teams from the U.S. and abroad. The competition will be played under FIH Rules and Regulations.

The registration fee is \$65/player with a team deposit of \$400 required by August 31, 2009. The final payment is due on the night of registration, Friday October 2, 2009. This fee includes a **Welcome Reception** on Friday evening and a **Dinner Banquet** (one ticket per player) on Saturday evening.

Our host hotel for the tournament is the **Renaissance Hotel Atlanta Downtown**. Their guest room rate for the tournament is \$123 plus tax for up to four (4) persons per room. **In order to lock in the room rate of \$123, hotel reservations must be made before September 2, 2009.** Please use the following link to reserve hotel rooms:
