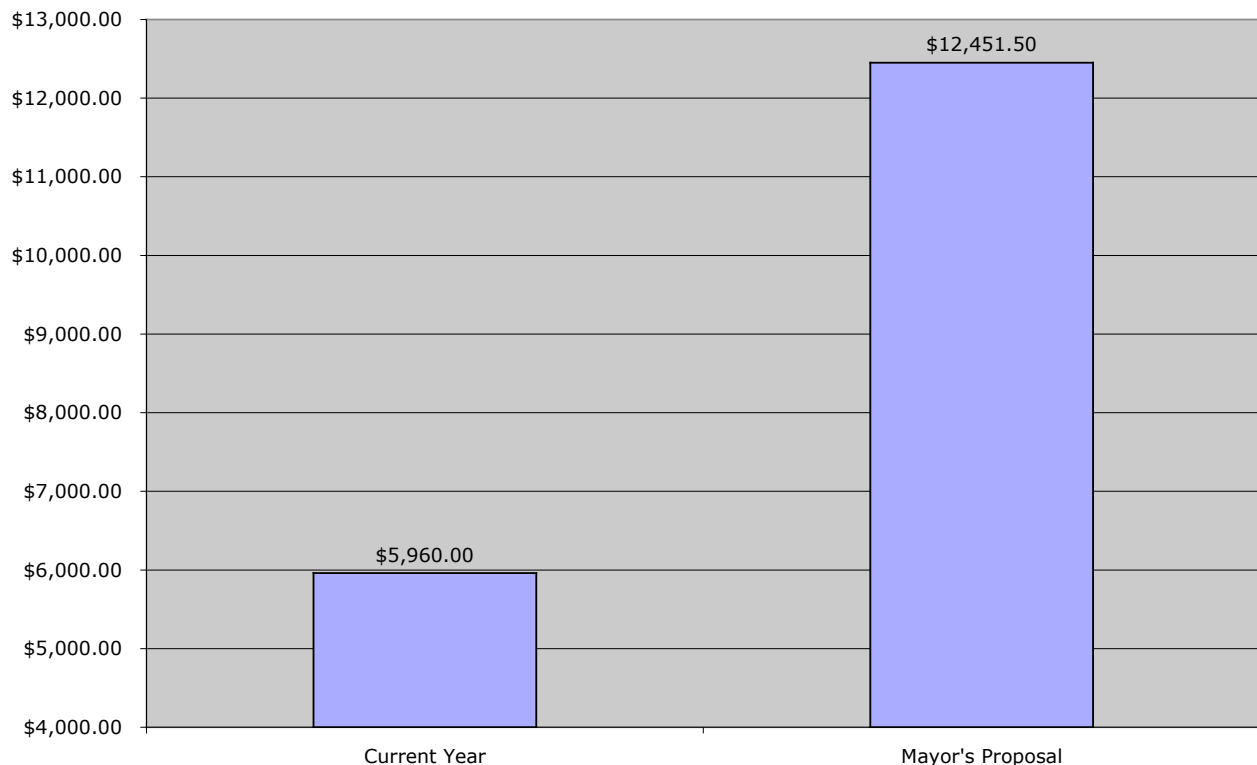

The Mayor's Property Tax Proposal



Typically, when property assessments double, mil rates (the calculation to determine property tax) are nearly cut in half. The Mayor's proposal leads to a 200–300% increase in taxes. Furthermore, it proposes a way to take an elderly person's home through "deferments", a disguised way to take your home away. The proposed dramatic increase will be passed on to renters. If the mayor gets his way, once the increase is in effect, you should expect to pay at least **\$155 more per month (\$1,860/year)** in rent for the same apartment – just to cover the tax increase.
