RHYCSS Junior Sailing Registration Packet

To all prospective Rock Hall Yacht Club Sailing School Students and Parents/Guardians:

Please fill out one complete set of forms (pages 3 through 5 of this packet) for each student and return to the RHYC Sailing School at the above address. Your check for payment payable to “RHYC Sailing School” must accompany the enrollment form. Your student's enrollment will not be complete until the registration forms **and** payment are received. These forms must be mailed in, as legal signatures are required.

Note that we are a Sailing School, not “sailing camp.”

This is a full course of education and learning. Attendance by your student is expected, rain or shine, every day of the school, except in cases of illness or a family emergency. We do not offer partial courses. If you desire special scheduling, private lessons are available.

There is a deadline for enrollment, which is seven days prior to the course you have chosen. Our classes fill up quickly so please register early. Do not expect confirmation of enrollment. Once your registration has been filled out and mailed with your check, you may not hear from the school unless there is a problem with space for your student.

On the final day of each Learn-to-Sail course we have a **Graduation Ceremony** to recognize each student's accomplishments. It is important for you and your student to participate in this final event from approximately noon – 1:00 pm on the last day of school. All family members are welcome! Please bring cameras and a side dish, beverage, or dessert to share.

PARENTS PLEASE READ!

To ensure the safety of your child when involved with the Rock Hall Yacht Club Sailing School activities, this form **MUST** be filled out for each child. The form will be filed in the Sailing School office, and will accompany the child on any trips away from the club along with a signed permission slip. This form will be required to be on file for any junior participating in any event. All information will be kept confidential, except as needed by a medical professional in case of an emergency.

Authorization and Consent

I, the undersigned parent/guardian of _____, a minor, do hereby consent to any emergency X-ray, anesthetic, medical or surgical diagnosis or treatment and hospital care which is deemed advisable by, and is to be rendered under the general or special supervision of any physician and surgeon licensed under the provision of the Medical Practice Act.

It is understood that this authorization is given in advance of any specific diagnosis, treatment, or hospital care being required, but is given to provide authority and power to give specific consent to any and all such diagnosis, treatment, or hospital care which the aforementioned physician in the exercise of his or her best judgment may deem advisable; and neither said agent or any organization involved assumes any financial responsibility for exercising this action. Privileges and Responsibilities Contract

Attire: Please mark all equipment with the student's name!

All students must wear:

1. U.S. Coast Guard-approved lifejacket. The jacket must fit properly.
2. Shoes - flip-flops are not acceptable - water shoes and/or water sandals are preferred.
3. Sunglasses and sunscreen (minimum SPF15)
4. Hat - not a visor
5. Club-issued T-shirt and other weather-appropriate clothing

NOTE: Acceptance of this registration is contingent upon the student's passing the swimming test, which will be conducted on the first day of class.

Responsibilities:

1. All students are to remain on club grounds during the class hours.
2. All class-related driving is to be done by designated adults only.
3. Until dismissal by the instructor, a student (and parent) shall not consider the day ended, and may not leave the club grounds.
4. No student may infringe on another student's rights or in any way compromise the quality of another student's experience.
5. All students shall treat each other, the instructors, boats, equipment, club buildings and grounds, and club personnel with respect.
6. Each student is responsible for his/her own equipment. Students shall not use or borrow something that does not belong to them.

Liability:

If a student is skippering a boat and an incident occurs in which he/she is at fault, the student/parents will be responsible for the damage. It is the student's responsibility to report all damage claims to the instructor on the day that the incident occurred.

Telephone:

Parents may reach their children by calling the instructor on his/her cell phone or contacting the RHYC at 410-639-2182 Unless it is an emergency, students may not use the club phone.

Safety:

1. Lifejackets must be worn by the students at all times when they are on the water. Un-fastened lifejackets are not acceptable.
2. Water sandals/water shoes must be worn by the students at all times.
3. Sunglasses must be worn while the student is on the water, and the student must bring his/her own container of drinking water.
4. Please consider your child's health, and include sunscreen (minimum SPF15) and a hat, not a visor.

Parent Involvement:

1. Parents/guardians are expected to deliver student to class and pick up student from class on-time.
2. Parents/guardians are requested not to interfere during the classes, leaving encouragement and instruction to the qualified instructor(s).
3. Parents/guardians may help out with stowing boats and equipment only if a thunderstorm is imminent or if time is of the essence.
4. Parents/guardians are expected to accompany their student(s) for the Graduation Barbecue at 5 p.m. on the last day of class.

Behavior resulting in unhappy or unsafe conditions will not be tolerated. Before registering, please consider these questions: 1. Does my child really want to learn to sail or race? 2. Does my child exhibit the maturity necessary to manage himself/herself on the water and to cooperate fully with the supervising adults? 3. Will my child handle himself/herself in a friendly and respectful manner toward the adults, peers, and the boating equipment? If you answered NO to any of these questions, please re-consider enrolling your child. We have a limited amount of time to teach sailing, racing, water safety and sailing-related etiquette. Please do not send a child to Sailing School if you know he/she cannot meet these behavioral expectations. The consequences for behavioral infractions are as follows:

- If the infraction is serious, the student will be immediately dismissed from the program.
- If the infraction is minor, the student's parents/guardian will be called to come and get the child immediately.
- If minor infractions are repeated, the student will be dismissed from the program.

Student Equipment Requirements

All students of the Rock Hall Yacht Club Sailing School will be required to bring to class each day:

1. A properly-fitted U.S. Coast Guard-approved lifejacket. (Please take your child to be fitted. The jacket should be snug, but not restrictive.)
2. Shoes, not flip-flops. (Water sandals, or heavy-duty water shoes are preferred.)
3. A hat - not a visor.
4. Sunscreen (minimum SPF15).
5. T-shirt provided by the Sailing School. (We purposely have these made in a bright yellow, so that students can be seen easily on the water.)
6. Sunglasses, preferably with a “croakie,” which is a tether that will hold the sunglasses on the student’s head or neck.
7. A container of drinking water. A sports bottle is ideal. Remember, the students are out in the hot sun for three hours!
8. A towel.
9. A snack and/or beverage.

Please mark all of the above items with your student’s name. It is helpful if you provide your student with a “gear bag” in which to carry these items to class. Items 1 through 7 are required - and failure to bring them will result in your student not being able to participate in class on that day.
