Rivergrove Woods East lot 14 Development Permit Application

At the Monday, February 6 meeting, the Planning Commission will continue its type II review for the development permit application for single-family house at Rivergrove Woods East lot 14 submitted by Renaissance Homes.

City Council Business

At the Monday, February 13 meeting, the City Council will continue its discussion of the draft sign ordinance (#81-2011) with possible subsequent adoption. Council will also discuss and consider adoption of Resolution 228-2012 for Workman's Compensation for Volunteers, give an update on the Capitol Improvement Project/Grant from the state, hear an update on the city archives project and discuss the formation of the 2012-2013 Budget Committee. A "Stop Ahead" sign at the approach of Childs Road and Sycamore will also be discussed.

Decisions

- The City Council adopted Resolution #227-2012 Accepting West Linn into the Metro Area Communications Commission. This has no financial impact upon the City of Rivergrove.
- The City Council adopted Resolution #229-2012 Adopting Policies and Procedures for Internal Control.
